## 2. SIT (State Implementation Team) Updates

- a. Choosing Sites for Actions in SEEDS
  - i. When promoting summer food sites or farmers markets, choose the sites being promoted (so the actual SFSP site or farmers market) when you report the action in SEEDS.
  - ii. Example 1: If you have a meeting at DES office to discuss Double Up promotion with the office manager, you would choose the farmers markets with Double Up as the sites (even though the meeting was with the DES office).
  - iii. Example 2: If you drop off SFSP flyers at a community center, you would choose the nearby SFSP sites (not the community center) when reporting the action.
  - iv. Refer to Appendix G on page 127 of the <u>SEEDS User Guide</u> for details.

# b. Choosing Resources for Actions in SEEDS

 i. A resource for the purpose of SEEDS is "a tool that describes implementation of an intervention within a PSE Strategy/Activity." A

- resource is not curriculum, handouts, learning enhancers, flyers, etc. Resources in SEEDS are those that guide your overall intervention.
- ii. Example: You may have a meeting with a school garden committee to plan for an upcoming work day among other things. Perhaps, you bring some copies of an Extension publication because you know they are having a pest problem in the garden. You would not choose the Extension publication as a resource because it is not guiding your overall intervention (which is to start and maintain the garden). Rather, you would choose something like *Arizona Gardens for Learning: Creating and Sustaining Your School Garden* which guides you in the larger intervention or PSE change.
- iii. If you are using a resource that's not listed in SEEDS, please send it to Jesse Davenport so she can add it: Jessica.Davenport@azdhs.gov.

- a. Farm Bill: House GOP leaders may compromise on conversation, commodity programs, and SNAP work requirements in order pass a bill by the end of the year. If they cannot, Congress will be looking at a 1-year extension of the current farm bill.
